<u>NEWS</u>

UK – This week the FCDO published the Final UK ODA Spend for 2023. <u>Bond</u> reports on the latest statistical release on Official Development Assistance, which presents final and detailed data on the UK's ODA spending in 2023. Overall, the picture looked positive in 2023, with total UK ODA increasing by 20% to £15,344 million (0.58% of GNI), helped by additional funding allocated to the ODA budget by the Treasury in order to manage the impact of large levels of ODA being used to support refugees in the UK. However, because in 2023 UK ODA for refugees rose to record levels (£4.3 billion, 28% of the UK ODA budget) and there were significant increases in multilateral ODA spending (by £2.2 billion, to £5.3 billion), the level of bilateral ODA available for the poorest countries and for supporting sectors vital to tackling poverty, marginalisation and insecurity, have continued to fall. Meanwhile, <u>Devex</u> reports that the U.K. will keep diverting its aid budget to cover refugee costs until reforms are in place. Action for Global Health, in conjunction with STOPAIDS and RESULTS, <u>composed a letter</u> highlighting concerns on future cuts, and will be distributing it to various targeted MPs to request they send it to the Treasury.

Radio 4's <u>'Sunday'</u> programme this week discussed the abortion clinic 'buffer zones' which have recently come into force in Scotland with similar areas on the way for England and Wales by the end of October, speaking to two women on either side of the debate.

A UK resident has been jailed for conspiring to commit female genital mutilation (FGM) against a young girl in the first conviction of its kind in England and Wales. A man from Swansea, arranged for the child to travel from the UK to Iraq where he had organised for her to be subjected to FGM and forced into marriage. <u>The Mail</u> and <u>BBC News</u> report.

Misinformation on social media is putting women off the contraceptive pill who are then risking unwanted pregnancies, according to the NHS. Dr Sue Mann, the NHS clinical director for women's health, called claims posted online that hormonal contraception causes infertility "damaging". She said: "Online misinformation about the pill and other forms of hormonal contraception is a real cause for concern — we are seeing young women coming into our clinics who have come off the pill as they think it could make them infertile. <u>The Times</u> and <u>The Mail</u> report.

Russia - The lowest birthrate in 25 years was recorded in Russia during the first half of this year, spurring the introduction of a bill as part of the government's efforts to counter the low birthrate by banning public advocacy for a child-free life. Nina Ostanina, the head of the Russian parliament's committee on family issues, said the law would make it illegal to write or say things such as "children are a burden" on social media or television. <u>The Times</u> and <u>News.com.au</u> report.

USA - A new <u>fact sheet</u> by the Guttmacher Institute's US federal policy experts details seven key ways Project 2025—led by the conservative Heritage Foundation—threatens sexual and reproductive health and rights. The Project 2025 policy framework outlines an agenda aimed at reversing civil and human rights across federal agencies. It includes attacks on medication abortion and contraception, along with efforts to undermine investments in reproductive health globally.

Joint Statement on Contraception - FIGO and ICM's joint statement highlights the importance of contraception in improving maternal and infant health, addressing risks like short inter-pregnancy intervals, maternal anaemia, and infant mortality. It calls for equitable access, especially in postpartum and post-abortion care.

VAWG Report - Womanity and the Center on Gender Equity and Health (GEH) at the University of California San Diego (UCSD) conducted a research study that sheds light on technical assistance and partnership models for adapting and scaling violence prevention programmes that better serve women and girls. This study aimed to identify facilitating factors, challenges and limitations of partnership models for adapting and scaling interventions, and to contribute to discussions on decolonising development, feminist funding principles and the ways in which donors can devolve power while supporting the work of women's rights organisations.

Feminist Foreign Policy – Last week at the Summit of the Future the Feminist Foreign Policy Collaborative shared a briefing on what to expect from governments with a Feminist Foreign Policy at the United Nations General Assembly (UNGA) and the Summit of the Future.
