

NEWS

UK – U.K. Development Minister Anneliese Dodds made her <u>first policy speech</u> at Chatham House this week. <u>Results</u> and <u>Save the Children</u> have released statements in reaction.

The Coalition for Global Prosperity latest launch, <u>'Renewed Commitment: Rebuilding Britain's Role in International Development'</u>, examines the vital role Britain will play across the world in promoting good health, empowering women and girls, and ending malnutrition. The collection was shared with MPs this week at an intimate reception with Bill Gates, Sir Ibrahim and Heela Yoon.

An increasing number of women who died between 2020-2022 during pregnancy or up to six weeks afterwards in the UK were known to social services, according to data released last week. This group makes up 22% of the 275 deaths reported, according to an MBRAACE report. The Byline Times reports.



On the back of their new <u>report on contraception</u>, which we reported on last week, BPAS have launched a <u>petition</u> to Wes Streeting MP, Secretary of State for Health to increase funding for contraceptive innovation.

USA - A new <u>survey</u> in the US found only a fraction of 15 to 29-year-olds receive information about contraception and abortion from health-care providers.

<u>The Record</u> reports that a "Pregnancy Crisis Center" has been accused of intercepting online communications from women booking abortions and contacting them offering spurious information.

Italy - Italy has made it illegal for couples to go abroad to have a baby via surrogacy after the senate voted on Wednesday in favour of a bill making it a 'universal crime'. Surrogacy, with or without payment, has been illegal in Italy for the last 20 years, but the newly-passed law extends the surrogacy ban to those who go to countries such as Canada or the US where surrogacy is legal. Kenya - The effects of climate change in Kenya are hitting girls' education hard, with more cases of early marriage, child labour and reduced school attendance due to extreme weather conditions. The Fuller Project report on the barriers young girls face as they struggle to pursue their education.

Cervical Cancer - Cervical cancer deaths have been shown to fall by 40 per cent under a new treatment, the biggest breakthrough against the disease for 20 years. The Times and Forbes report.

Climate change and SRHR – Two new studies have been published looking into the links between climate change and sexual and reproductive health and rights. 'Key considerations for research into how climate change affects sexual and reproductive health and rights' in The Lancet and 'Climate change and sexual and reproductive health and rights research in low-income and middle-income countries: a scoping review' in the British Medical Journal.

UNFPA - The United Nations Population Fund launched its new <u>"WomenX Collective"</u> programme at the World Health Summit in Berlin on October 15, in conjunction with the opening of its first hub office in a global network of centres specializing in the promotion of women's health, especially sexual and reproductive health, in the German capital. The Berlin office will be run in cooperation with Charité – Universitätsmedizin and the Berlin Institute of Health at Charité (BIH). With their new

partnership, UNFPA and Charité aim to promote women's health, particularly in middle- and low-income countries and to address the lack of solutions and financial resources in this field.
