NEWS

UK – This week Chancellor of the Exchequer Rachel Reeves presented Labour’s first budget since being elected to government. The budget includes departmental allocations for the Foreign, Commonwealth and Development Office (FCDO) for 2024-25 and 2025-26 and drops the Official Development Assistance (ODA) budget down from 0.58% of GNI in 23-24 to 0.5% of GNI for 24-25 and 25-26, which means a real terms cut for UK aid. Earlier this week APPG on Global SRHR Co-Chair Sarah Champion MP wrote a piece for [Devox](#) on her concerns ahead of the budget and has released a [statement](#) in her capacity as Chair of the International Development Committee.

In October 2022 a vote in the House of Commons saw MPs supporting legislation to introduce safe access ‘Buffer Zones’ around abortion clinics in England and Wales 297-110, underscoring a national demand for these protections. However, implementation faced delays, with the law finally passing in May 2023 but remaining stalled until last month. On 18 September 2024, the Home Office announced that the law introducing Safe Access Zones around abortion clinics will be brought into force from 30 October, two years after MPs voted to support this legislation. The fertility rate in England and Wales has collapsed to a record low, according to new data. The number of babies born per woman was 1.44 in 2023, compared with 1.49 the year before, and is the lowest since records began in 1938, according to figures from the Office for National Statistics (ONS). The House of Commons has formally appointed the membership of the [International Development Committee](#). Sarah Champion MP, who was confirmed as Chair some weeks ago is now joined by Labour party colleagues Laura Kyrke-Smith MP, Noah Law MP, Alice MacDonald MP, Gordon McKee MP, Sam Rushworth MP and David Taylor MP, David Mundell and David Reed from the Conservative Party and Monica Harding and Brian Mathew from the Liberal Democrats.

USA - All eyes are on the United States right now because the current U.S. election could have critical—and global—implications for the future of women’s rights, sexual and reproductive rights, and the right to abortion. [Euronews](#) and [BBC News](#) report.

A young Houston woman’s death has put an increased focus on Texas’s abortion laws just days before the general election. According to reports, the 28-year-old mother was 17 weeks pregnant

Inter-Parliamentary Union (IPU) Assembly - Hundreds of parliamentarians, from some 130 countries, gathered at the 149th IPU Assembly in Geneva and adopted a [resolution](#) reaffirming unwavering support for multilateralism through the United Nations system and other global institution and a landmark resolution on [The impact of artificial intelligence \(AI\) on democracy, human rights and the rule of law](#). The resolution urges parliaments worldwide to swiftly develop and implement robust legal frameworks and policies for the responsible creation, deployment and use of AI technology.
