- Called for strong government commitment to implement the APPG's key policy recommendations, including:
 - A Healthy Homes and Buildings Government department and Minister responsible for increasing future health and wellbeing.
 - Healthy Homes legislation to provide for greater accountability and responsibility for Health and Wellbeing in all homes and buildings.
 - Health and wellbeing principles adhered to by landlords, housing providers, builders, planners and local authorities.

Reiterated the urgency for legislative action to address these issues and improve health and wellbeing through building health into housing.

KEY POINTS

Focus Beyond New Builds

• Emphasised that the current pace of construction means that most of the homes and buildings we need to make healthy will be existing stock over new builds - stated that 80% of the homes we live in will already be built.

National Retrofit Strategy

- Mentioned her role as Chair of the National Retrofit Hub
- Highlighted the importance of a comprehensive national retrofit strategy, framing health and wellbeing as having clear economic and social benefits

 retrofitting generates nearly double the revenue for every £1 spent, sustains approximately half a million jobs, and delivers savings to the NHS by improving health outcomes.
- Advocated for the locally driven retrofit projects, ensuring solutions are tailored to community needs.

- Warned that a narrow focus on carbon reduction can harm health and wellbeing in homes and buildings, citing issues such as mould and damp
- Used the example of heat pumps- if not properly used can lead to increases in running costs particularly for users with constrained budgets

User-Centric Modelling

- Stressed that retrofit models must be designed around the needs and behaviours of occupants.
- Without a user-centric approach outcomes are likely to fall short.
- Called for real time monitoring of users in homes to analyse how behaviours can lead to poor choices that can cause problems such as mould and damp.

Accompanied Incentives

• Concluded with the need for incentives for users, paired with reliable sound advice to ensure effective and sustainable implementation.

KEY POINTS

Link Between Housing Conditions and Crime:

- Margaret noted that while the connection between poor housing conditions and crime is recognised, there is limited robust evidence to fully demonstrate this link.
- Whilst there are studies that examine the 'broken window analogy' that links poor quality homes and community spaces to increased levels of crime and anti-social behaviour - more can be done to reflect the link between unhealthy homes and buildings and levels of crime.

Decline in Communal Areas:

• Highlighted the deterioration of communal spaces in many housing developments, which has contributed to issues such as lawlessness and antisocial behavior.

Case Study: Millard Terrace, Dagenham - 'Britain's Worst Estate'

• Millard Terrace is a key example of where poor housing is causing negative outcomes in terms of health and wellbeing and overall community cohesion.

• Emphasised that when people are proud of their homes and surroundings, it fosters a stronger sense of community and belonging, which can positively impact social behavior.

Role of Landlords and Legislation

- While acknowledging that many landlords maintain good standards, Margaret pointed out the existence of rogue landlords who exploit tenants.
- Stressed that legislation plays a vital role in addressing these issues, creating better homes and ensuring accountability.

Stronger Regulation

• Advocated for stronger regulatory frameworks, noting their potential to significantly improve living conditions and enhance residents' quality of life.

Concluding Remarks

• Underscored the importance of addressing disrepair, strengthening regulations, and fostering community pride as essential steps toward creating healthier and safer housing environments that have the potential to create safer and healthier streets.

MISSION 3: Healthy Homes are key to Building an NHS Fit for the Future

KEY POINTS

Experience and Advocacy

- Highlighted over 30 years of involvement in health and care issues, emphasising the strong connection between good-quality housing and overall health - worked for the King's Fund
- She noted her work with the Centre for Ageing Better and role as Co-Chair of the APPG on Housing for Older People.

Issues of Cold and Damp Homes

- Addressed the significant problem of cold and damp housing, citing the tragic case of Awab Ishak and the deaths of children and young people caused by poor living conditions.
- Highlighted the increased risk of respiratory diseases associated with such environments.

Mission to Improve Population Health

• A shift towards preventive measures in health was emphasised, with Anna noting that improving the population's health is only achievable if homes are healthy and safe.

Policy and Action Priorities

- Advocated for an increase in the Disabled Facilities Grant to improve accessibility for individuals with disabilities.
- Stressed the importance of ensuring accessible and well-designed housing that supports healthy ageing and living.

Retrofitting and Learning from Experts:

- Retrofitting the existing housing stock was identified as a critical priority to address current issues.
- Emphasised the need to learn from designers and planners to create healthier, more accessible living environments.

Standards in the Private Rented Sector (PRS):

 Advocated for the establishment of clear standards in the PRS, highlighting the opportunity for the APPG to contribute to the development of the proposed Renters' Rights Bill.

Rented Property Database

- Emphasised the positive move to introduce a national database of rented properties, which could provide increased transparency for tenants.
- Suggested that the database should include key information such as EPC ratings and the health quality of rental properties.

- Jenny Riddell-Carpenter MP, Gideon Amos MP, Lord Alan Haselhurst
- Underscored the importance of providing tenants with better access to information about their rental properties, enabling them to make more informed decisions.

Concerns About Space Standards

- Reiterated his long-standing opposition to the abolition of space standards, noting the importance of maintaining such regulations to ensure adequate living conditions.
- Pointed out that even with space standards in place, some individuals are still living in single-room accommodations, highlighting a broader issue of overcrowding and affordability.

Application to Serviced Accommodation

• Stressed that the same standards proposed for rental properties should also be applied to serviced accommodation, ensuring consistency across the housing sector.

Concluding Remarks

• Highlighted the need for robust standards in the private rented sector, increased tenant transparency, and comprehensive databases to improve housing quality.

Public as a Catalyst for Change:

- Addressed the importance of engaging the public as a driving force for achieving goals, advocating for clear communication free of jargon to ensure broad understanding and support.
- Stressed the need to frame discussions around comfort, affordability, and family benefits to resonate with people's everyday priorities and improve health and wellbeing in homes and buildings.

Decarbonising Homes:

- Noted that 30 million homes in the UK need to be decarbonised.
- **Residential properties account for 14% of the UK's energy usage**, underscoring their significant role in addressing the climate crisis.

- This approach ensures greater public engagement and commitment to the journey toward net zero.

Landlords and Housing Pressures

• Increasing pressure without adequate support is causing many landlords to sell properties, reducing housing stock.

Audley English - Buildeco Offsite Architecture

Innovation in Assessment:

• Currently developing an app for assessing mould and damp in existing buildings.

Challenges with Retrofitting:

• Retrofitting must ensure properties remain viable for at least 60 years to meet mortgage requirements.

Insurance Issues

• Insurance companies are a critical but often overlooked stakeholder in the retrofitting process.

Need for Long-term Solutions:

- Highlighted the inadequacy of short-term fixes, like painting over mould.
- Stressed that healthy homes require enduring solutions beyond current legislation like the Housing Health and Safety Rating System (HHSRS).
- Raised concerns about how "Awaab's Law" might not fully address long-term mould prevention.

Environmental Health

Partnerships and Legislation:

- Advocated for changes to the licensing scheme to remove barriers and improve outcomes.
- Encouraged partnership working with the NHS, such as "Healthy Homes on Prescription."

Simplifying Regulation

• Called for simplification of existing regimes and better funding integration.

• Emphasised the need for a unified approach that includes acoustics as a critical component of healthy home design.

Jade Lewis- Jade Advocacy

Holistic Retrofit Programmes:

• Called attention to the lack of focus on acoustics and lighting in retrofit programmes, citing lessons from the 2016 White Paper.

Simon Harpin - BEAMA

Missed Opportunities in EPC Reform:

- Current reforms fail to address health metrics like ventilation and air quality, focusing solely on energy efficiency.
- Highlighted the need for broader interventions that encompass health issues.

Lisa Malyon- TariffChecker.UK

Ventilation and Behavioural Change:

- Stressed that ventilation is a critical safety element in healthy homes.
- Highlighted issues like heat pumps increasing bills, underlining the need for behavioral education.

Challenges in Retrofitting:

- Noted that 20% of retrofits lead to damp and mould problems, with 80% of insulation improperly installed.
- Urged investment in training and preparing the next generation of building professionals.
- Emphasised the importance of educating residents on maintaining healthy homes.

Tassos Kougionis - McBains

Design and Implementation Failures:

Criticised the lack of design capability in contractors working under PAS 2035 standards.Proposed creating a safety net for retrofitting processes and ensuring proper validation of work to prevent unintended consequences.

Jeremy Proteus - Housing and Learning Improvement Network

- Integrating Care and Housing:
 - Asked how housing could become part of integrated care systems to improve population health outcomes.

Temporary Accommodation Concerns:

- Raised alarm about the over 150,000 children living in temporary accommodation and its detrimental health impacts
- .Highlighted poor examples of conversions under permitted development rights, such as office buildings in Ilford's Newbury Park area.
