

All-Party Parliamentary Group on Immigration Detention

Inaugural Meeting – Minutes

1. Welcome

1.1 The chair welcomed attendees to the inaugural meeting of the APPG on Immigration Detention. She spoke about her motivations for establishing the group, including the problems she and other MPs were seeing on a regular basis through immigration detention-related casework.

1.2 The chair explained that immigration detention charity Medical Justice would provide secretariat services to the new group.

2. Aims of the APPG on Immigration Detention

2.1 Elspeth Macdonald outlined the proposed aims of the new APPG: to increase understanding within Parliament of immigration detention in the UK; connect parliamentarians with relevant research, experts and organisations, including people with lived experience of detention; and advocate for evidence-based policy reforms and the welfare of detainees.

2.2 The chair then invited Members to highlight the issues they would be keen to raise or explore further through the group. Issues mentioned were:

- a) Large-scale use of immigration detention in the UK
- b) Immigration detention as an issue impacting both rural and urban constituencies
- c) Home Office decisions to detain/release lack of transparency
- d) Suicide and self-harm in detention
- e) Situation for women and families
- f) Situation for victims of torture
- g) Lack of access to legal advice, interpreters and other services
- h) Ongoing threat of detention during reporting process impact on health, including mental health

It was suggested that the group might ask colleagues to share constituents' experiences of immigration detention. It was also suggested that the Chair write to the Immigration Minister once the group was registered, to invite her input and engagement.

3. Introduction to secretariat

3.1 Emma Ginn explained that Medical Justice provides medical advice to people in immigration detention in the UK, including arranging independent medical visits and reports. The organisation worked with over 80 volunteer clinicians and 100 volunteer interpreters, and handled over 1,000 detainee referrals per year. It was active in all immigration removal centres across the country.

As well as its work with individual detainees, Medical Justice also undertook wider research, advocacy and litigation to bring about systemic policy change.
