The APPG members noted areas of work that had not been completed in 2021:

The APPG noted that BUILA had recently completed a code of practice for education agents and would welcome more information on this area of work.

The APPG members noted additional areas to explore for 2022/23 and recommended a meeting with the Co-Chairs and Secretariat to explore how these might be addressed:

- Gathering of evidence on challenges on work placements short sharp enquiry
- Improving the application experience for students and universities: Application fees
- De-risking markets for students by creating escrow accounts to prove maintenance funding
- Challenging the list of nationalities identified as lower risk and subject to differential (lower) evidence requirements
